UPDATE ON RECENT DEVELOPMENTS SINCE SUSPENSION OF TRADING

References are made to the Company's announcements dated 13 June 2012, 19 September 2012, 27 November 2012, 21 January 2013 and 21 February 2013 in relation to, among other things, the Incident and the Potentially Unlawful Events (the "**Announcements**"). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those used in the Announcements. This announcement is made by the Company to inform the Shareholders and potential investors of the development of the matters relating to the suspension of trading in the Shares of the Company.

As stated in the Company's announcements dated 27 November 2012, 21 January 2013 and 21 February 2013, the Company has been in discussions with TGL about possible ways to resolve and settle the Incident. The Board wishes to inform the Shareholders that the Company and TGL have made progress in the past month as to possible ways to resolve and settle the Incident. The Company has also been informed that certain Shareholders and shareholders of TGL have engaged in discussions to resolve and settle certain issues in relation to the Incident. The Board will continue to work with TGL towards settlement of the Incident. However, as at the date hereof, the Company has not yet entered into any legally-binding agreement to settle the disputes with TGL regarding the Incident and has not agreed to terminate any legal proceedings against TGL. The legal actions taken against TGL as highlighted in the Announcements have continued to be put on hold.

The Company will issue further announcement on the progress of the Incident and the Potentially Unlawful Events as and when appropriate before the publication of the 2012 Results Announcement, the 2012 Annual Report, the 2012 Interim Results Announcement and the 2012 Interim Report.

Trading in the Shares on the Stock Exchange has been suspended with effect from 9:00 a.m. on 8 June 2012 at the request of the Company. Trading in the Shares will remain suspended until further notice.
